1	Page 3 Sr. No. 5 of Addendum-I (Amendments to RFP Section-2 (ITB),Eligible Bidders / Eligibility Criteria, Clause 2.5, Page 8	The bidder should have had an annual turnover of at least Rs. 2 Crores (<i>Rupees Two Crores</i>) in each of the last three financial years (i.e. 2015-16, 2016-17, 2017-18) and should be profit making in each of these years.	The bidder should have had an annual turnover of at least Rs. 2.00 Crores (Rupees Two Crores) in each of the last three financial years (i.e., 2015-16, 2016-17, 2017-18) and should be profit making in at-least last two of these three years (i.e, 2016-17 & 2017-18).
